# SUBLEASING EDUCATIONAL LANDS

1. No Educational Lands held under lease shall be subleased without the written approval of the Board of Educational Lands and Funds.
2. Application to sublease must be made on a form approved by the Board and must be subscribed to under oath by both the Lessee and the Sublessee. For each lease considered for sublease, a separate application must be submitted.
3. A copy of the Farm Lease or Sublease Agreement must accompany the application. If the Farm Lease or Sublease Agreement should change at any time, the Lessee shall notify the Board of such change within 30 days.
4. Whenever an application to sublease is made, the land shall be subject to reclassification.
5. A sublease filing and recording fee in the amount of ten dollars (\$10.00) per lease plus twenty cents (\$.20) per acre for each acre to be subleased must accompany the application for subleasing Educational Land to defray the expenses involved in the supervision of the subleases. Fees should be paid by the Lessee, and shall be refunded if the application is rejected by the Board.
6. If a field inspection is necessary, all expenses incurred beyond the fee of twenty cents (\$.20) per acre remitted with the application shall be paid by the Applicant.
7. Applications to sublease Educational Land shall be on a year to year basis. Applications for renewal shall be made at least thirty days prior to the expiration of an existing, Board approved sublease.
8. Both Lessee and Sublessee must be cooperators with the local Soil Conservation District and must carry out the program of conservation operations upon the Educational Land in accordance with the Rules and Regulations of the Board. All conservation improvements and operations recommended by the Conservation District must be approved by the Board of Educational Lands and Funds prior to the time such operations, or improvements are commenced.
9. Rental, delinquent interest and all fees must be paid to date before a sublease agreement will be approved.
10. All rules, regulations, and covenants which apply to the present lease and Lessee shall also be binding on the Sublessee.
11. Both the Lessee and the Sublessee will be held strictly accountable for the observance of all covenants of the lease.
